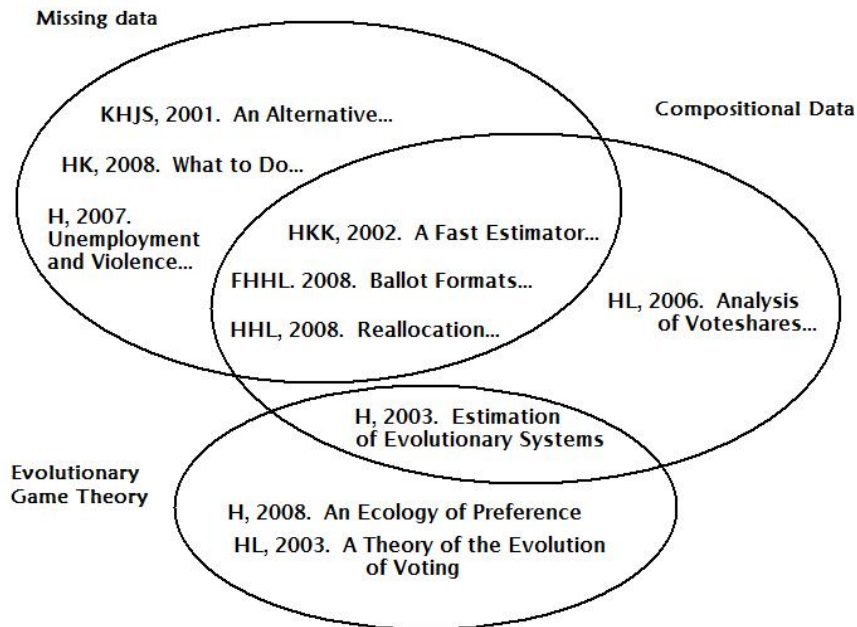


Figure 1: A Venn diagram showing the relationship of these published and working papers across the research topics of missing data, compositional data, and evolutionary game theory.
